Federal retirement, life insurance, health care, COLA's, compensation and other benefits for both current and retired federal employees are complex and often amended. The Local Chapter 256 in Fort Collins has about 150 members with about 40 who attend the monthly luncheons. Membership is comprised of people that worked/work at all levels and in most Departments/Agencies of the Federal Government. Most members are retired with the average age for the group probably early to mid-70s but includes people from their 40s to their 90s. Some members are very physically active and many are very socially

active in the community. While most members are retired some work full time and some work or volunteer part time in areas related to their professions or in areas where they have an interest. Several members worked for land management agencies; Forest Service, Fish and Wildlife, Park Service, Bureau of Land Management and Bureau of Reclamation. Several worked/work for the Rocky Mountain Forest and Range Experiment Station and USDA-ARS. Others retired from the Extension Service and a few are involved with CSU. Agencies like the EPA, FAA, Post Office, IRS, DOD and Foreign Services are also represented.
